I Meeting called to order

The Scott Township Board of Supervisors' monthly business meeting was called to order on October 21, 2025 at 7:10 p.m. at the Joe Terry Civic Center, 1038 Montdale Road, Scott Township, PA 18447. The meeting was opened by Supervisor Giannetta with the Pledge of Allegiance. In attendance were Supervisor Giannetta, Supervisor Russell, Attorney Fanucci, Township Administrator Carl Ferraro, and Secretary/Treasurer Diana Campbell. Supervisor Brenzel called in.

II Zoning

1. Nichols lot line change. The property is located on 347 in Justus. The property line is being moved to keep the garage with the other buildings. The remaining lot is 30,000 sq. feet, which is acceptable since there is central sewer and water.
2. Henzes/Lawler lot line change. This will remove a non conforming lot. Three lots will become two lots. No new lots are created.
