September 16, 2025

I Meeting called to order

The Scott Township Board of Supervisors' monthly business meeting was called to order on September 16, 2025 at 7:15 p.m. at the Joe Terry Civic Center, 1038 Montdale Road, Scott Township, PA 18447. The meeting was opened by Supervisor Giannetta with the Pledge of Allegiance. In attendance were Supervisor Giannetta, Supervisor Russell, Supervisor Brenzel, Attorney Fanucci, Township Administrator Carl Ferraro, and Secretary/Treasurer Diana Campbell.

II Zoning

1. Von Storch minor subdivision—This subdivision would split 4.48 acres into three lots. Lot 1 would be 1.45 acres and include an existing one-story commercial structure and two-story "barndominium". Lot 2 would be 1.14 acres and include an existing building and pool. Lot 3 would be 1.9 acres and include an existing garage and shed. Scott Township Planning Commission recommended approval with the condition that the stormwater is controlled should a driveway be put in.
2. Bowen Lot Line Change—This would be a land swap between two land owners, however only one owner signed the application. The application was denied by the planning commission because there was no co-applicant. Attorney Fanucci recommended the Supervisors deny this application and that Mr. Bowen begin with a new application. He stated that the Township is under a timeline to take action. Mr. Bowen stated he would like the township engineer to review the plans. He was made aware that any extra costs for professional services would be his responsibility.

Mark Cordelli of Lackawanna County shared with the public several upcoming events and services offered by the County. George Homick, of the Scott Township Veteran's Committee, asked Mr. Cordelli what plans the County has to celebrate America's 250th birthday. Mr. Cordelli reported that there is a committee and they are just beginning to make plans. He also mentioned that a grant is available for each municipality to use toward a celebration.

Mr. Ferraro provided an update on the Senior Center renovations. The project is nearly complete with just a few more items to finish. CDBG funds from 2020 were used. For 2025 funds to be used, a project needs to be prepared in advance. The front ramp will be repaired and new handicap accessible doors will be installed at the top of both ramps.

III. Public Comment on Agenda Items

Rose Knick asked if solar farms and wind farms would be included in the discussion on data centers. She questioned Attorney Fanucci's bill for the Mr. Bowen and Pivot Energy and whether these would passed along. She asked when the police contract would be available for public review, what the Reaper's fee would be for parking. She inquired about the agreement with the Sewer Authority and if there was a job description.

VII Discussion

LERTA

Attorney Frank Hoegen provided the supervisors with information regarding a LERTA for the land where his client, Core 5, intends on developing. He pointed out the tax advantages over a 10 year period and asked the Supervisors to consider moving forward with approval. Attorney Fanucci questioned when the LERTA would take effect and the timeline should the supervisors wish to move forward. Attorney Hoegen stated there would need to be resolution signed, subject to approval of the school district and the county.

Data centers, solar farms and wind farms

Supervisor Brenzel stated that he would like to update the zoning ordinance to reflect data centers. He would like to use some aspects from Jessup Borough's ordinance. Attorney Fanucci cautioned against using the ordinance in its entirety, since boroughs and townships follow different codes. He suggested using key points from several ordinances and tailor it to Scott Township. Supervisor Giannetta agreed that the ordinance needs to be updated. Attorney Fanucci questioned the Supervisors as to where they

would want to place these land uses. Supervisor Brenzel stated he only wants to allow in the Industrial Zone (ID zone). Supervisor Giannetta and Supervisor Russell agreed.

Police Contract

Supervisor Giannetta stated that Supervisor Brenzel worked with the Police to negotiate the new contract. It includes a 3% raise, but nothing else.
